Please note (as per the API DSC constitution):

1. For the post of Chairman Vice Chairman, the candidates should have been elected members of the API-DSC Governing Body for at least one term of office.
2. No member shall be eligible to seek election consecutively for more than two terms as Chairman or Vice Chairman.

Note: 'Term' means the period extending from one annual general body meeting to the next annual general body meeting. Turn means two terms as described above.


3. Governing Body members shall not hold office for more than three turns.
4. Past Chairman shall not seek election for any of the elected positions in the Governing Body.
5. A member cannot contest for more than one office bearer's post viz. Chairman, Vice Chairman, Hony. Secretary or Hon. Treasurer during one election.
6. One nomination paper can be used for one post only. Photocopy of the nomination paper can be used to apply for different posts.

The nomination duly proposed and seconded by valid members on the nomination paper, along with the consent of the candidate, should reach the undersigned by 30 April 2026, 3:00 PM.

Withdrawal of names can be done by 14 May 2026, 3:00 PM.
