**Subject: Circulation of Unverified, Unsubstantiated, and Unsigned Message on WhatsApp (Since 22 April 2026)**

This is to bring to the attention of all members of the medical fraternity and others concerned that an unverified, unsubstantiated, and unsigned communication has been circulating across multiple WhatsApp groups. The content of this message portrays the API-Delhi State Chapter (API-DSC) in a negative light.

The undersigned categorically denounces the said communication and its contents as baseless, frivolous, false, and motivated. It appears that the sole intent behind this circulation is to disrupt and undermine the ongoing democratic election process of the API-Delhi State Chapter.

It is pertinent to note that certain members of API-DSC had recently been issued clarificatory notices for actions contrary to the interests of the Association. The current vilification campaign seems to be a direct consequence of these actions.

Allegations such as the delay in elections are unfounded, especially when the election process is currently underway and has been duly notified (details available at [www.apidsc.in](http://www.apidsc.in)).


Further, the selective dissemination of bank statement details—reportedly obtained through unauthorized means—and their misrepresentation to imply wrongdoing is misleading and unjust. The records in question merely reflect reimbursement of legitimate expenses incurred by office bearers, who, in the face of limited funds inherited by the present administration, personally financed academic activities in the interim. All such transactions are subject to due audit.

It is also noteworthy that, for the first time, API-DSC Life Membership list has been displayed publicly by the current Gov. Body. Additionally, the academic initiatives and their content remain transparent and open for scrutiny by all members.

Resorting to social media platforms to discredit committed and sincere members of the Association is inappropriate and condemnable. It is equally unfortunate that some senior members of the fraternity appear to have been misled and inadvertently drawn into propagating this misinformation.

All recipients of such messages are urged to verify facts before forwarding. WhatsApp group administrators are also requested to exercise due diligence and refrain from facilitating the spread of unverified and potentially malicious content.

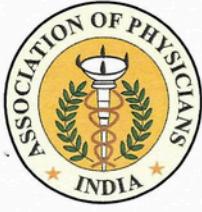

### Sub: Formal Clarification in Response to Allegations and Ongoing Defamatory Campaign Against the Office Bearers of API-DSC

It has come to the attention of the undersigned that a series of unverified, misleading, and prima facie defamatory communications are being circulated by certain members of APIDSC, with apparent tacit endorsement from a few senior individuals. Such communications appear to be calculated to malign the reputation of the present Office Bearers and to create unwarranted discord within the association. In order to place the correct factual and legal position on record, the following clarifications are hereby issued:

**1. Extension of Governing Body Tenure-** The extension of the Governing Body (GB) tenure in the year 2023 occurred under the leadership of Dr. M.P.S. Chawla (Chairman) and Dr. Atul Bhasin (Secretary), in a year when no Annual General Meeting (AGM) was convened. The said extension continued until March 2024, despite elections being due on or before 31 October 2023 (copy of minutes, in the handwriting of Dr. Atul Bhasin, annexed). It is pertinent to note that the said extension was not ratified by the General Body in any duly convened AGM, thereby raising serious concerns regarding its procedural and constitutional validity.

In contradistinction, the present Governing Body has strictly adhered to the constitutional mandate by ensuring that elections are conducted annually within the prescribed timeline.

**2. Approval of Life Memberships-** All Life Membership applications have been duly scrutinized and approved by the Governing Body in accordance with established procedure. Records demonstrate that memberships up to serial number 1038 stood approved as of 23 May 2025, bearing the signatures of all competent office bearers, including Dr. Atul Bhasin (document annexed). Subsequently, an additional 24 memberships were approved on 28 March 2026, bringing the total to 1062. Any allegation to the contrary is factually incorrect and misleading.

**3. Alleged Deletion from Life Membership Register-** Allegations regarding deletion of names from the Life Membership register are baseless, unsubstantiated, and denied in toto. No deletions have been effected by the present Governing Body, save and except in cases of deceased members, which is an administrative necessity.

**4. Financial Transactions and Related Allegations-** The unauthorized procurement and circulation of bank statements by individuals lacking due authority raises serious legal and ethical concerns, including potential breaches

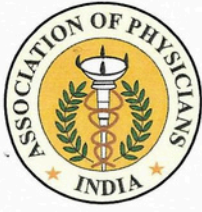


of confidentiality and fiduciary norms. Furthermore, selective extraction and misrepresentation of financial data appears to have been undertaken with the sole intent of causing reputational harm to the present Office Bearers.

At the time of formal handover in March 2024, the previous leadership (Dr. M.P.S. Chawla and Dr. Atul Bhasin) transferred a balance of approximately ₹6,00,000 (document annexed). It is a matter of record that the organization of a two-day annual conference in Delhi entails a minimum expenditure of approximately ₹20–22 lakhs. Despite these constraints, the Annual CME at India Habitat Centre was successfully conducted. A substantial portion of the expenditure was initially borne personally by the Honorary Secretary, including ₹2,00,000 via credit card and ₹4,11,486 via cheque, in addition to other cash expenditures (supporting documents annexed). The total sum of ₹6,35,589 was reimbursed after a period of four months upon availability of adequate funds.

It is further clarified that the cheque issued in the name of “Shalini Sharma” pertains to “Shalini Sharma Travels,” as substantiated by documentary evidence. Any truncation or omission in bank statements is attributable solely to formatting or space constraints and does not reflect any irregularity. All payments referenced have been made against valid invoices, including ₹3,93,782 to Hitesh Pathak (KUVI Travels, Bill No. 43241) and ₹3,00,000 to Sonam Sharma (Hind Tours), in connection with the event held on 23 August 2025 (PALM 2.0 at Le Méridien, Delhi).

**5. Unauthorized Use of Digital Signature Certificate (DSC)**  
It is a matter of serious concern that the Digital Signature Certificate (DSC) of Dr. Atul Bhasin has reportedly been utilized by him for filing Income Tax Returns without authorization from the present Governing Body. Simultaneously, a contrary and misleading narrative is being disseminated in public forums. A formal explanation from Dr. Atul Bhasin in this regard is awaited, and appropriate action shall be considered upon receipt of the same.

This statement is issued in good faith to apprise all stakeholders of the true and correct position and to uphold the principles of transparency, accountability, and constitutional governance. The present clarification should not be construed as an engagement with individuals pursuing a motivated and mala fide campaign driven by vested interests. The association reserves its right to initiate appropriate legal proceedings, civil and/or criminal, against any person(s) found to be disseminating false, defamatory, or misleading information.

An awareness programme was also conducted on occasion of World Hypertension Day in association with Dept of Medicine, LHMC.


A programme COSM 2.0 was also scheduled to be held on 5th July 2025 at IHC & live-streamed to satellite centres around NCR of Delhi.


